*This workshop will explore some of the options that cities have to improve air quality management, both within the city limits as well as within the wider region in which they are located. It will highlight some of the challenges cities face when working to improve air quality and present examples how these have been overcome.*

*In addition, the European Environment Agency will take the opportunity of the workshop to launch its new 'Air quality in Europe -2017' report, presenting participants with key updated information on the status of air quality across Europe.*

*Many European cities – more than 130 cities – face air pollution above the standards set in European Union air quality legislation and/or guidelines provided by the World Health Organization. Across the continent, this leaves almost one in three citizens in urban areas exposed to levels of air pollution legislation deems harmful, with adverse health risks.*

*Air pollution is an area where the European Union has been particularly active for more than thirty years. And yet, as the comprehensive Environmental Implementation Review published by the European Commission earlier this year shows: more needs to be done to bring all Member States into compliance with current air quality standards as soon as possible.*

*Our cities play a key role in this regard. On the one hand, cities are often disproportionately affected by poor air quality, including due to background concentrations caused by national as and international emissions, primarily from industrial and agricultural activities. On the other hand, cities themselves tend to contribute much to air pollution, especially as regards transport, households and energy emissions.*

*Achieving improved air quality will require effective implementation of existing legislation, notably on national emission ceilings and on various emission sources in the industrial, energy, transport and agricultural sectors. It will however also require further efforts at the city scale, especially to reduce air pollution hot-spots in cities, where and when they occur.*

*The workshop forms the 10th meeting of the CoR/EC Technical Platform for Cooperation on the Environment, which seeks to contribute to a better implementation of EU environment law.*
